

Spotlight on The Community Action Partnership for Madison County

The Community Action Partnership for Madison County was founded in 1983 and works with Low to Moderate Income (LMI) families to provide education, guidance and accessibility to resources for families and individuals striving toward economic self sufficiency. The agency serves one in every 16 residents of the county. CAP for Madison County provides Early Childhood Programs, Special Education Advocacy and Youth Mentoring to Individuals. For families, the agency provides Family Action, Self-Sufficiency/Stabilization and Housing Assistance. They provide food pantries and resources and help with health care to the community. Additionally, the agency provides Nutrition Outreach and Education Program (NOEP) services to Otsego County. CAP for Madison County has partnered with the CASH Coalition of Madison and Chenango Counties to provide Volunteer Income Tax Assistance (VITA) services for fourteen years. Last year over one million dollars in refunds were obtained for over 500 filers. The agency works with the Mary Rose Clinic to ensure those in most need of medical care (the uninsured, age 16+) receives medical services including free prescription drugs and lab services.



The agency has created a Resiliency Model for service delivery. This theory of change provides a clear and concise way for the agency to communicate their strategies, services and accomplishments with their community partners and stakeholders. CAP for Madison County was recently awarded \$590,000 for the 1st Time Homebuyer's Program through the New York Community Development Block Grant. The award will be used to assist LMI families to become first time home owners. Maximum grants of \$30,000 will be made - for closing costs and principal reduction. If the recipient stays in the home for ten years, there is no repayment required. The current maximum price for a home is \$125,000 and up to \$5,500 in

closing costs can be covered. In order to qualify for the program the participant may not have owned a home previously OR may be a displaced partner/homemaker. Participants must also meet the HUD income guide lines: (One person household- \$38,400; two person household- \$43,850; three person household- \$49,350; four person household- \$54,800; five person household- \$59,200; six person household- \$63,600; seven person household- \$68,000 and 8 person household- \$72,350). Participants must be pre-qualified through an initial screening and then are assigned a Housing Counselor. In addition to meeting with the Housing Counselor, the participant must attend six one on one classes, completing the 12 hour Homebuyer's Education Class. The agency's Loan Review Committee then reviews the application and makes a final decision on awarding the grant and determining the maximum purchase price.
