

New Shelter

Mohawk Valley Community Action Agency is set to open a new shelter by November 1 for homeless and runaway youth, the first in their community. The shelter will be located in Rome, NY and will serve youth from throughout Oneida County. The shelter will be able to house six youth at one time and is targeted to serve youth 18 and under for 21 days. MVCAA Executive Director Amy Turner, highlighted the importance of this service noting that they will "be able to offer some temporary shelter to those youth for whom, going back home isn't an option or isn't a good setting for them."

Bullying Prevention Month. In addition to October being Domestic Violence Awareness month, it is also Bullying Prevention Month and this October the campaign is celebrating their 10 year anniversary with a decade together against bullying - united for kindness, acceptance, and inclusion. National Bullying Prevention Month is a nationwide call to action, providing schools, parents, and students with the educational resources to support and better respond to bullying behavior. Research published in the American Journal of Public Health finds that kids and teens from low-income families are more likely to be bullied than others and that schools with larger economic inequality had higher rates of bullying. Energy Saver 101: Home Heating. With the colder weather approaching and The Weatherization Program celebrating their 40th anniversary this month, Engery.gov shared a great infographic on home heating and energy saving tips. Some of the tips mentioned in the graphic include:

- Opening your curtains in winter months to bring in sunlight and naturally heat your home.
- Use a programmable thermostat to set your heater back while you are away or asleep.
- Set your ceiling fan to spin clockwise to blow the rising hot air down.

Race, School Ratings, and Real Estate: A 'Legal Gray Area'. Advocates for fair housing see a potential problem with the close ties between school ratings and the effects it has in real estate. They say the common denominator for these stats, too often, is race. The problem has intensified in the last decade with new web platforms bringing information directly to home-buyers such as school rating maps, which too closely mirror a racial dot map. That, in turn, raises some complicated questions about how factors like test scores and school ratings are used to influence home-buying decisions.

For realtors, directly discussing the racial composition of a neighborhood with potential home-buyers is against the law, however, a 2006 report from the National Fair Housing Alliance (NFHA) shows documentation of some form of racial steering in 87% of these encounters. A striking pattern regarding schools emerged from these tests. For example, white testers reported they were told to avoid Tarrytown, NY schools, serving predominately Hispanic communities and that the schools were "bad", but Latinos were told the same schools were "good."

Sites such as Zillow, state these data points serve as a starting point to do further research and connect with a real estate professional, but the use of color coding, and the ready availability of information about demographics is still cause for concern. If a realtor were to hand a home-buyer Census stats showing race and ethnicity of the neighborhood, it would most likely be an FHA violation. Click here to read the full story.
